

## **STOKENHAM PARISH COUNCIL PRIVACY NOTICES**

### **Contact – Privacy Notice**

**When you contact us** the personal information you provide (such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

### **Chillington Playing Field Hire – Privacy Notice**

**When you hire the Village Hall** or hold an event on the Playing Field, the personal information you provide (such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence, provide information, send invoices and receipts relating to your hire agreement. Your personal information will not be shared with any third party without your prior consent.

### **Councillor – Privacy Notice**

**When you sign your acceptance of office** and take your seat on Stokenham Parish Council the personal information you provide (such as name, address, email address, phone number, register of interests and other relevant information) will be processed and stored so that it is possible to contact you, respond to your correspondence and retain information relating to your time in office with the Council. (The Council asks that you provide a dedicated email address for conducting Council business). Your personal information will not be shared with any third party other than those related to a statutory or lawful requirement or with your consent.

### **The Council's Right to Process Information**

General Data Protection Regulations Article 6 (1) (a) (b) and (e)

Processing is with consent of the data subject or

Processing is necessary for compliance with a legal obligation or

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

### **Information Security**

Stokenham Parish Council has a duty to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested. We will only keep your data for the purpose it was collected for, and only for as long as is necessary, after which it will be deleted. You may request the deletion of your data held by Stokenham Parish Council at any time.

### **Children**

We will not process any data relating to a child under 13 without the express consent of the parent or guardian of the child concerned.

### **Access to Information**

### **Information Correction**

### **Information Deletion**

### **Right to Object**

### **Rights Related to Automated Decision Making and Profiling**

Stokenham Parish Council does not use any form of automated decision-making or the profiling of individual personal data.

**Summary:** In accordance with the law, Stokenham Parish Council only collects a limited amount of information about you that is necessary for correspondence, information and service provision. Stokenham Parish Council does not use profiling, nor sell or pass your data to third parties. Stokenham Parish Council does not use your data for purposes other than those specified. Stokenham Parish Council makes sure your data is stored securely. Stokenham Parish Council deletes all information deemed to be no longer necessary. Stokenham Parish Council constantly reviews its Privacy Policies to keep it up to date in protecting your data.
